Concerning: **Pre-registration of substances in Toner Containers**

Applicable: All subsidiaries / Distributors of Kyocera Mita Europe B.V. in the EU.

Dear Customer,

As already known REACH entered into force on June 1st 2007 and will be phased in over an 11 year period (until 2018). Its main goal is to screen both existing and new chemicals for environmental and health risks.

REACH applies to all industries conducting business in the EU. The main impact of REACH will be on the chemicals industry but there are also requirements affecting articles manufacturers.

Substances contained in toner containers are required to be pre-registered with the European Chemicals Agency (ECHA) between June 1st 2008 to December 1st 2008 by the manufacturer (for toner manufactured in the EU) or by the importer / only representative of the extra-EU manufacturer (for toners manufactured outside of the EU).

If a new substance will be used in toner containers after the pre-registration phase, it has to be registered directly, as is the normal case for new substances in Europe.

Your position is to be a "downstream user" with no obligation besides to ensure that your supplier have done the pre-registration of substances contained in toner containers according to REACH.

In order to confirm that, Kyocera Mita Europe B.V. as your supplier will sign the below declaration to acknowledge compliance to the REACH pre-registration obligations.

1. Pre-registration.

Kyocera Mita Europe B.V. in the Netherlands ensures that Kyocera Mita Europe B.V. which is assigned by Kyocera Mita Corporation in Japan as only representative or Only Representative which is assigned by manufacturer of substances which compose our toner (upstream maker) have completed REACH pre-registration for substances contained in toner containers.

2. Pre-registered substances and Pre-registration numbers.

Due to the trade secret reasons the pre-registered substances, Only Representative other than Kyocera Mita Europe B.V. and the pre-registration numbers can not be made public.
